## CASE STUDY

### University struggled to keep pace with disconnected systems

As a legacy Emburse customer, Pace University understood the benefits of automating expense management. Still, with an average of 1,000 expense reports and credit card reconciliations each month, the AP team struggled with a primarily manual audit process. Pace implemented a third-party audit solution to address this challenge, but this resulted in more issues.

According to Regina Beatty, Pace’s Director, Accounts Payable, AP still spent more than 10 hours per month manually auditing, spot-checking, and dealing with false positives across two disconnected systems. This was because the third-party audit solution lacked integration with their Emburse expense solution. The compliance rules set up in their Emburse expense solution did not consistently translate into the audit tool, which flagged items incorrectly or not at all. Additionally, the tool could not separate expense reports and credit card reconciliations, which created more work for AP to double-check receipts and re-categorize expenses.

When Beatty learned that Emburse Audit fully integrates with their Emburse expense solution and includes both technology and human audit components, she couldn’t wait to switch.

## Audit solution eliminated 100% of manual auditing

With their prior audit tool, the university's AP team manually audited 25% of all expense reports and credit card reconciliations because there were so many inconsistencies between systems. A key benefit of upgrading to Emburse Audit was the automatic integration. Rules that already existed within Pace University's Emburse expense solution integrated seamlessly into Emburse Audit, centralizing the entire process and eliminating errors.

Emburse Audit's built-in rules and machine learning-based technology work in the background auditing Pace University's expense reports and credit card reconciliations. Any items the system flags as non-compliant automatically get sent to a human auditor for further review. Independent auditors then work directly with employees to resolve issues, with little to no intervention from the university's AP team. "A huge benefit of Emburse Audit is the independent auditor service. I have confidence in the technology itself, but knowing there are human eyes on any issues upfront before expense reports even reach our approvers is invaluable," said Beatty.

With Emburse Audit's technology-assisted expense audit service, manual auditing is a thing of the past. "The audit process is fully integrated within our Emburse expense solution," explained Beatty, "We no longer manually audit anything since we're 100% confident in the Emburse Audit solution. While we still spot-check certain items, we've reduced our volume of spot-checking by 75%, which has cut the amount of time AP spends on the audit by more than half." The team is now able to spend more time on higher-impact work.

In addition to saving time, Beatty raved about an unexpected benefit: increased end-user ownership. Since implementing the solution, she's seen a significant decrease in the volume of returned expenses due to missing receipts. Employees are submitting all required information upfront since they know their submissions will go to an auditor if there's anything missing.
